Our Safeguarding Policy and Safeguarding Procedures will be reviewed annually by Attenborough Arts Centre's Advisory Board. These documents will be regularly monitored and updated in the event of any incident or update in legislation by AAC's Designated Safeguarding Officer (DSO) and Deputy DSOs.

1. Definitions

Child: Working Together to Safeguard children defines a child as ‘anyone who has not yet reached their 18th birthday’. The fact that a child has reached 16 years of age, is living independently or is in further education, is a member of the armed forces, is in hospital or in custody in the secure estate, does not change their status or entitlements to services or protection.

Young person: The term young person may be used to acknowledge the maturity of children as they reach adulthood. For the purpose of this policy, ‘young person’ refers to anyone under the age of 18 who is still a child in the eyes of the law unless we refer specifically to a young person as being over the age of 18

Adult at risk: Safeguarding duties apply to an adult who:

- has needs for care and support (whether or not the local authority is meeting any of those needs)
- is experiencing, or at risk of, abuse or neglect
- as a result of those care and support needs is unable to protect themselves from either the risk of, or the experience of abuse or neglect

Safeguarding: Safeguarding is the action taken to promote the welfare of children and adults at risk and protect them from harm.

Child protection: Specifically deals with cases where a child is at risk or experiencing significant harm, taking reactive measures to protect them.

2. Purpose of this policy

The purpose of this Safeguarding Policy is:

- To protect children and young people under the age of 18 who engage with or receive Attenborough Arts Centre services from all types of harm and maltreatment. This includes the children of any adults who engage with our services and activities.
- To support a culture of safeguarding to be upheld and promoted at Attenborough Arts Centre.
- To ensure that all staff, volunteers and anyone working on our behalf are aware of the principles and guidance that sits behind our safeguarding approach.
- To ensure that children and their families are aware of the guidance and principles that guide our safeguarding approach.

Attenborough Arts Centre’s Safeguarding Policy applies to anyone working on behalf of Attenborough Arts Centre, which includes the Advisory Board, Senior Management team, paid staff, freelance and sessional workers, volunteers, students on work placements, agency staff and anyone else acting on our behalf.

3. Policy Statement

Attenborough Arts Centre is the University of Leicester's public centre for art and culture. Annually, we welcome 100,000 people of all ages and backgrounds to visit art exhibitions, performances and a wide range of creative activities in our building, offsite and online. Our Learning & Community programmes for people of all ages receive 24,000 engagements each year. These include Creative Courses and programmes for children and young people, families, schools as well as dedicated programmes for SEND (Special Educational Needs and Disabilities) children and young people. We also work directly and with a range of Community Partners who work with adults at risk. We have a longstanding track record in disability arts.

We believe that:

- The welfare of children, young people is paramount and we have a responsibility to keep them safe.
- Children and young people have a right to protection from all types of maltreatment, harm and abuse.
- We will give equal priority to keeping all children and young people safe regardless of their age, disability, gender reassignment, race, religion or belief, sex, or sexual orientation.
- Some children and young people may be additionally vulnerable because of the impact of discrimination, previous experiences, their level of dependency, communication or any other additional needs.
- Working together in collaboration with children and young people, their families, carers and other agencies is essential in delivering effective safeguarding practices.

4. How we communicate and train workers and volunteers about safeguarding

Everyone working at Attenborough Arts Centre (AAC) including Advisory Board members, paid workers, freelance staff and volunteers, will:

- Be given AAC-specific safeguarding and child protection training as part of their induction.
- Be given information about the University of Leicester's IT and social media usage policy and how IT and social media usage is monitored.
- Be given enhanced training if working directly with children, young people and adults at risk.
- Be given other relevant CPD training relating to safeguarding as required as part of their role.
- Be given the opportunity to participate in discussions about safeguarding held regularly during team meetings to encourage a culture of safeguarding e.g. by identifying particular programmes for staff to be aware of.
- Be invited to attend at least one information refresher session per year on AAC's Safeguarding Policy and Procedures, to be held in advance of the annual Advisory Board review and reported to the Advisory Board.

Everyone working at AAC who is also a University of Leicester employee will:

- Take University of Leicester Safeguarding mandatory training once per year.
- Participate in discussions about any aspects of safeguarding during Performance Development Discussions (PDDs) as appropriate.

6. Our Commitment

We are committed to actively safeguarding all children and young people from harm and maltreatment by:

- Having an appointed Designated Safeguarding Officer (DSO) and two Deputy DSOs.
- Having an appointed Attenborough Arts Centre Advisory Board member who takes the lead on behalf of the Advisory Board for safeguarding at the highest level in the organisation.
- Provide effective management of staff and volunteers with regard to their safeguarding responsibilities through training, support and audits.
- Continually developing our detailed safeguarding, child protection and Adults at Risk policies and procedures in order to reflect best practice nationally, seeking external consultancy as required.
- Listening to Adults at Risk and respecting them.
- Ensuring that Adults at Risk, their families and support staff know about our Safeguarding Policy and Procedures and what to do if they have a concern.
- Create a culture of safeguarding in which all staff, Advisory Board, freelance artists and volunteers feel comfortable sharing concerns.
- Implementing a Code of Conduct for all staff and volunteers and ensuring that they know how they are expected to fulfil their role.
- Implementing Safer Recruitment practices.
- Storing and recording data in a secure and appropriate manner.

- Disseminating information to those we work with if required.
- Making clear in our Safeguarding Procedures how we work with external parties including the Safeguarding Partnership.
- Making clear in our Safeguarding Procedures how we manage allegations.
- Making clear in our Safeguarding Procedures how we address bullying.
- Making clear in our Safeguarding Procedures our whistleblowing policy and procedures.
